Theme	The film must carry an environmental message and if possible, suggest action.
Length	Up to 5 minutes MAXIMUM
Deadline	5.00pm Friday, 9 September 2022
Who may enter	Entry open to all and can be individual or group entries. All entries welcome, please be aware that most entries are from children and young adults. Only one entry per individual.
Main Categories	Early childhood centres/kindergartens – preschoolers and their teachers. (may be adjusted due to numbers entered) Primary school - person or group from this age group and their teachers. High school - person or group from this age group and their teachers. All comers - open to any person, group or company.
Format	In the best quality you can manage on: .mov, .avi, .mp4, .m4v
Media	Email, upload (e.g., Dropbox) or USB drive.
Content	Can be video, slides, animation or any combination of these. Can be factual or fictitious, serious or humorous, real or acted. If you have made an environmental film for other purposes, you are entitled still to use it for this competition. No advertising, bad language, no indecent images, and no unauthorised use of other people's material.
Prizes	A panel will choose the winners. Prizes will be awarded at a public showing. The overall winner will receive the Kea Trophy.
Use and Rights	Screening By submitting your film, you grant us the right to show your film, to live audiences or online. This does not preclude your right to also screen the film as you see fit.
